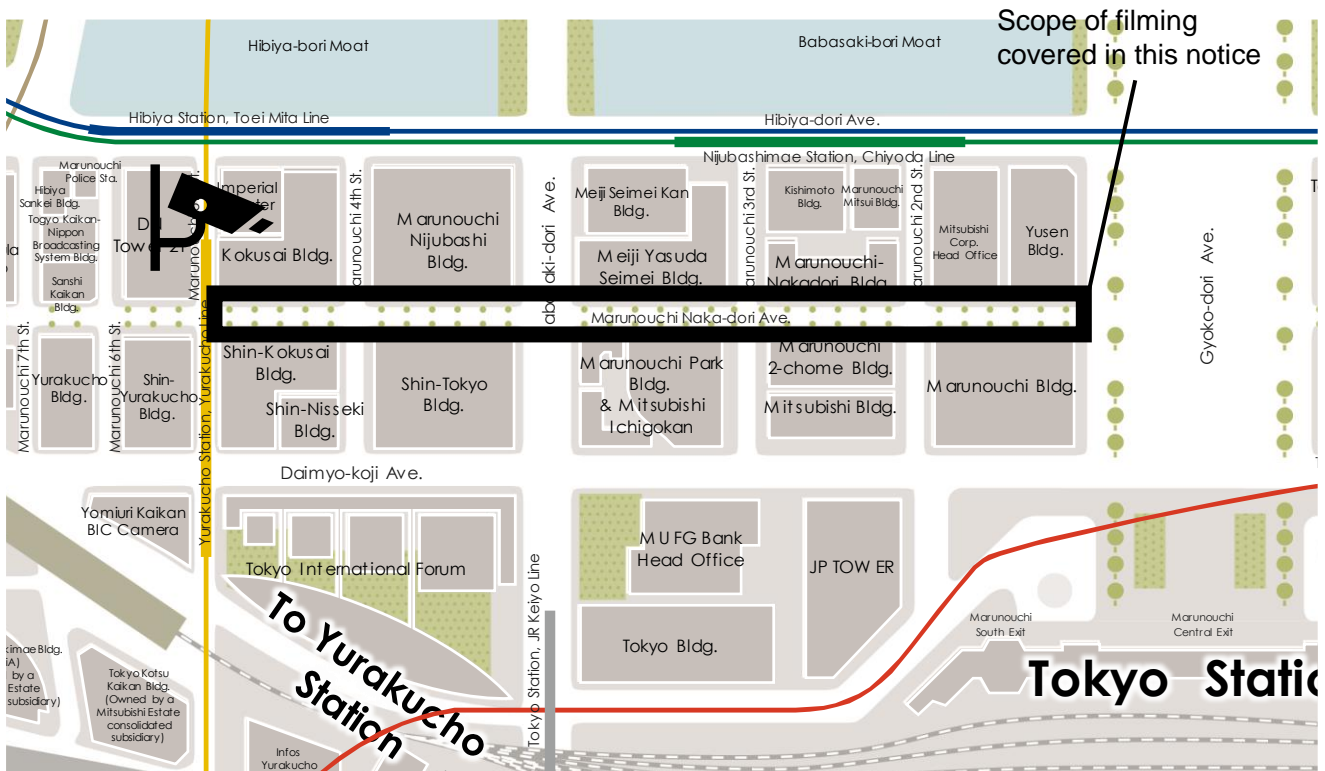


NOTICE REGARDING THE CAMERAS INSTALLED IN THE FIVE BLOCKS AROUND MARUNOUCHI NAKADORI STREET

(The English version is prepared as a reference and the real text should be in Japanese.)

The Council for Area Development and Management of Otemachi, Marunouchi and Yurakucho* and Mitsubishi Estate Co., Ltd (hereinafter 'the Acquirers'), will acquire images of public spaces from cameras installed in the Otemachi, Marunouchi and Yurakucho areas.

(*In February 2023, utilizing Chiyoda City's subsidies for the installation of security equipment, and in March 2025, utilizing Tokyo Metropolitan Government's smart pole and sensor utilization project for the smartification of the city, cameras were installed in the scope of filming below.)



The images acquired may include facial images and personal information.

[Objectives of the use of acquired images]

In addition to the everyday prevention of crime etc. the images will be used to prevent the occurrence of accidents and trouble during events and the coming and going of people in the evening. They will also be used to realize area development with safety and peace of mind for all people who visit or work in the town.

[Outline of acquisition and use]

- The data acquired from the cameras is not facial feature clustering data.
- The Acquirers will jointly use the acquired images in conjunction with the enterprises involved in the management and use of the public spaces covered. Please refer to the section below 'regarding joint use' for more details.
- The acquired images may, pursuant to legal stipulations, be shown or provided to the police or those involved in disaster prevention and preparedness measures.
- The Acquirers and joint users may conduct AI image analyses of the acquired images, and create statistical data in order to ascertain state of use regarding management and use of public spaces. The camera images are able to distinguish specific individuals, but the statistical data obtained after the analysis will not be used to identify specific individuals. Please refer to the section 'regarding content of AI image analysis' below.
- The acquirers and joint users will in principle store the images filmed for seven days. However, exclusively in the event that it is possible that phenomena such as crime, earthquakes or the mass influx of people occur, images may be stored for long periods in order to record and conduct follow-up verifications of the images in question.

【 Regarding the management of image data 】

- The Acquirers will, with regard to the image data acquired, conduct the requisite and appropriate management measures such as controlling access and appointing managers.
- The Council for Area Development and Management of Otemachi, Marunouchi and Yurakucho promotes area development planning that respects the purport and content of the Otemachi-Marunouchi-Yurakucho Area Development Guidelines formulated by the Advisory Committee on Otemachi-Marunouchi-Yurakucho Area Development. As the public spaces in and around Marunouchi Nakadori Street are managed and used through public-private collaboration and numerous stakeholders, together with the above-mentioned joint users the acquired data will be appropriately managed pursuant to the management and operation regulations.
- The Council for Area Development and Management of Otemachi, Marunouchi and Yurakucho will, with regard to the use of various types of data on the Otemachi, Marunouchi and Yurakucho districts, and the treatment of camera images of public spaces, proceed while gaining the opinions of an advisory board. <https://www.tokyo-omy-council.jp/topics/smartcity/2271/>
